Examples of Affiliate Members are engineering firms, environmental firms, law firms, end-users of NPs (i.e. ready-mix producers, highway pavers, cement and wallboard producers, block producers, precast producers, cementitious materials containing NP, etc.), universities, agricultural interests, and organizations or individuals that promote the use of NPs in green building and sustainable development, and general NP enthusiasts. (\$500/\$300 year depending on size—see next page)
